## LILIAN WATSON FAMILY HISTORY AWARD SOME COMMENTS FROM THE JUDGES

N behalf of the judging panel, I would like to record how much we all enjoy participating in the Lilian Watson Award and to compliment the Tasmanian Family History Society Inc. on its support and encouragement of family history research and publication through the Award.

There were sixteen entries for the award this year, a significant increase on the previous year and the judges were favourably impressed by the standard and variety of entries. There was great variety in approach to the subject and in the way different aspects of Tasmanian history were incorporated in the works.

While nobody writes a family history specifically for the purpose of entering it for this or any other award, there is value in publishing the judges' comments on the award for two reasons. First, it explains the process by which the judges reach their decision, and second, it can assist in raising the standard of publications in the family history field.

The judges work with a set of criteria and a marking schema which have been developed by the Tasmanian Family History Society Inc. First, they ask the question: "How successful is the work in presenting an interesting family history in the terms of the award—the story of a family, and/or individual, with a significant Tasmanian content?" (a possible 20 marks).

Other criteria specifically relate to:

• Presentation—the scope and detail of the history, the depiction of the family in its historical setting, historical accuracy, English expression, arrangement of material, quality of printing or typeface, quality of illustrations—photographs, maps, diagrams, and relevance of illustrations to the text (possible 40 marks);

- Indexing and genealogical tables—the accuracy and comprehensiveness of the index, and the clarity of genealogical tables and data (possible 20 marks)'
- References—the acknowledgment of sources of information, appropriate and full citation of references, the citation of sources either in a bibliography or list of references (possible 20 marks).

These criteria are more than a set of parameters for evaluating and comparing the entries in the Lilian Watson Award. They also form a useful set of guidelines and checklist for any writer setting out to produce a family history.

In the judges' experience over the last three years, the best entries were always successful in constructing an interesting narrative. While most entries presented valuable information in a clear and well-organised way, it was an added pleasure for us to read those entries which tell the story of a family or individual in a way which flows, establishes an historical context and holds the reader's interest throughout.

In respect of presentation there are two issues that are frequently discussed by the judges. One is the importance of proofreading. Many entries submitted over the last three years have clearly not been reviewed by an editor or proofreader. Before committing a manuscript

to the printer, all writers should take the precaution of having their work checked by a competent proof-reader or at least an acquaintance with a good knowledge of the subject matter and spelling and grammar. This would help eliminate typographical errors and spelling inconsistencies which inevitably detract from the finished work.

The second is the quality of reproduction of images, especially digital images. It can be very expensive to print high quality images and many publishers of family histories are working with a limited budget. However, with the increasing popularity and affordability of digital cameras and scanners, the judges are seeing more examples of poorly printed digital images. Resizing images, especially low-resolution images compressed formats, results in blurred and pixelated photographs which detract from the finished product. reproduction of digital versions of newspaper photographs is especially problematic, since the originals are often low quality screen prints. There are many opportunities for training and advice on digital image handling and we believe anyone preparing a family history publication should thoroughly research this area or seek advice on the best way to optimise the quality of their images.

With the increasing use in family histories of information gathered from the Internet, there is a need to stress the importance of clear citation of sources, including standard recording of URLs and inclusion of the date a website was visited. It is also important that researchers remember that information published on the Internet is only as reliable as the original source and should not be accepted uncritically.

Some entries in recent years have lacked important features such as an index, genealogical tables and bibliography, or list of references. It is very difficult for a family history to win the award if it lacks these features. More important, inclusion of an index and bibliography make the book a much more valuable resource for the reader and researcher. The judges also recommend the use of a recognised style guide, such as the *Style Manual: for authors, editors and printers* an Australian publication readily available in public libraries, to achieve a standard approach to citations.

I am especially pleased to have the opportunity to present these comments because it allows the judges to provide feedback to past and future entrants.

#### THE AWARD

The judges were unanimous in their recommendation that the Lilian Watson Award for 2003 should go to Judith Borrick for her book *Holycross; the story of the O'Mara family*.

This outstanding family history is a very well-researched and written account of a fascinating Tasmanian family which is connected with a series of significant people, places and events in the history of the state. The inclusion of the family's Irish background and the reasons for their transfer to Tasmania adds great interest to the story and sheds valuable light on conditions in Ireland of relevance to any researching Irish Tasmanian their connections. The author's original illustrations are an important additional personal contribution to the story. The account of the O'Mara family is a very readable history, filled with character, drama, suspense and incident. Holycross met all judging criteria to an outstanding level. The book is a fine example of family history writing which transcends

the genre to produce a work of wide general interest.

The judges also wish to acknowledge another entry of very high quality J A Evans' Frederick Matthias Alexander; a family history. This is a biography of a significant international figure which includes valuable Tasmanian content. The first part of this book deals with Alexander's forebears, family and his early life in Tasmania and its importance in shaping his character and his later It is another example of a work. thoroughly researched and well-written family history. Particularly noteworthy are the very high production values of book, including professional this indexing, excellent design and printing and a very high standard of bibliographic information

## **BOOK REVIEW**

HOLYCROSS: THE STORY OF THE O'MARA FAMILY, Judith Borrick.

The Author, (Indooroopilly, Queensland, 2003).

This book is an excellent reminder that generalisation about history can be misleading. It gives a thorough picture of a family settling in Van Diemen's Land, illustrating some commonly-held beliefs, but challenging others.

The Mara family farmed in Tipperary, in Ireland, where Philip Mara was a witness to the murder by Irish rebels of an unpopular land agent. His testimony enabled the rebels to be brought to justice, and in retaliation, other rebels killed his brother. The family gained protection from the British government, and eventually, in 1830, moved to Van Diemen's Land. The difficulty, poverty and lawlessness of Irish life are vividly described and we're reminded that not all Irish were convicts, and not all uneducated.

In Hobart, various family members had differing fortunes, though they were assisted by being accepted into and sometimes employed among the closelyknit—but quarrelsome—Catholic community. All family members' lives are described, chapter headings such as 'Timothy the rogue', 'Mickey the hermit', 'Philip the bolter' and 'the saga of Mary O'Mara' telling their own story. It's a very good picture of colonial life, in many areas of Tasmania. The British Government's reneging on a promise to help the family, petty and not so petty crime in Tasmania, adventures on the goldfields, forced migration to New Zealand—no fiction writer could dream this up!

The book is written in a very readable and lively style. There are some slips natural to a Queenslander who hasn't grown up with a knowledge of Tasmanian history (Louise Meredith, Glen Due) but overall, it's an excellent addition to Tasmanian history.

## FEMALE FACTORY MUSTER

N Sunday 7 November, 2004 at the Cascades Female Factory Historic Site, Degraves Street, South Hobart, the first muster of female convict descendants in Australia will take place.

Female factories were established around Van Diemen's Land (Tasmania) in the colonial period. They housed female convicts as they waited to be sent out on assignment, waited to bear children, and if they needed to be punished. Thousands of female convicts and their children passed through the factories, though it is not always possible to see this from the records

The Female Factory Muster will commemorate convict women and their children during an Open Day. Descendants of the women will be encouraged to enter their names on the Muster's database, which will be designed and later maintained by members of the recently formed (February 2004) Female Factory Research Group, an initiative of the Board of the Female Factory Historic Site, Ltd.

It does not matter whether the female convict spent time at a factory or not—all descendants of all female convicts who spent time in Van Diemen's Land are welcome.

The day will also feature events of interest to those who have no personal connection with the female convicts, but would like to learn more about them and their experiences. The Muster has been approved as a Bicentennial event.

## LETTER TO THE EDITOR

HE Other Side of the coin? An observation on the article about Elizabeth Fry.

In their schooling years many have the story of Elizabeth Fry included as part of the curriculum. There is little doubt that this lady did sterling work among those unfortunate souls who were waiting transportation to the various penal settlements and deserves her place in recorded history. Little however, would appear to have been made public on other aspects of her life—which does make an interesting comparison.

Several failed attempts to colonise New Zealand were made in the early 1800s, one of these being the New Zealand Company, headed by Edward Gibbon Wakefield. Some thirteen years later, a second New Zealand Company was formed, headed by George Lambton, Earl of Durham and having as its directors Edward Gibbon Wakefield, his cousin Elizabeth Fry and Joseph Somes.

That Elizabeth Fry, wife of a banker, who while encompassing the Quaker faith, would deign to associate with her cousin Edward Gibbon Wakefield, and Joseph Somes, does require an answer.

Edward Gibbon Wakefield had spent a certain time in prison, having been convicted of abducting a young schoolgirl as his second wife.

Joseph Somes was, in the early 1800s, one of the largest private English shipowners and in those days was making a 'pretty penny' by transporting convicts to the British Colonies. George Lambton was a coal baron

The directors of this New Zealand Company are a coal baron, and a shipping magnate, the wife of a banker, plus the promoter of the original settlement scheme, Edward Gibbon Wakefield

Little seems to have been noted on this commercial association by Elizabeth Fry, but one must be tempted to seek an answer in the old adage—does money talk?

Elizabeth Fry died in 1845 the same year as Joseph Somes, so her association with the New Zealand Company was only for a few years.

## THE 'RAJAH QUILT' PROJECT

Muriel Bissett (Member No. 755)

AS your female ancestor aboard the female convict barque *Rajah*?

July 19 arrived the barque *Rajah*—Ferguson, master, from London 5th April,

with 179 female prisoners and 10 children.

Surgeon, Superintendent, James Donovan.<sup>1</sup>

Also on board was a quilt which had been patiently by the stitched women on the long 105-day iourney from Woolwich to Hobart The quilt,2 which still survives, bears a neatly embroidered inscription:

To the Ladies of the Convict Ship Committee

This quilt worked by the Convicts of the ship Rajah during their voyage to Van Diemans (sic) Land is presented as a testimony of the gratitude with which they remember their exertions for their welfare while in England and during their passage and also as a proof that they have not neglected the Ladies kind admonitions of being industrious June 1841.

The 'Ladies of the Convict Ship Committee' refers to the committee of ladies set up originally by Elizabeth FRY to assist convict women who were being transported. The committee organised for each woman to be issued with a bundle of goods which included haberdashery and

two pounds (a little less than a kilogram) of patchwork pieces. It was thought that the patchwork would give the women some occupation during the long journey, and moreover, if the guilt was sold, give

the women a little monev towards their new lives. Elizabeth Frv<sup>3</sup> described the usefulness of patchwork in a pamphlet she wrote about female prisoners.

Formerly, patchwork occupied much of the time of the women confined in Newgate, as it still does that of the female convicts on the

voyage to New South Wales. It is an unexceptionable mode of employing female prisoners, if no other work can be procured, and is useful as a means of teaching them the art of sewing.<sup>4</sup>

The *Rajah's* journey to Van Diemen's Land went smoothly, and the surgeon reported that

the weather was fortunately very fine during the early part of our passage. The heat became oppressive between the decks in the tropics, but fortunately this resulted in no other ill effects than severely trying the tempers of the Women <sup>5</sup>

According to the report of the Ladies Committee in 1842:

convicts on the *Rajah* were, as usual, supplied with various article of clothing, besides haberdashery, materials for needle-work and knitting (in order to afford employment during the voyage).<sup>6</sup>

The female convict ships allowed a few passengers: the clergyman referred by the report was the Revd R DAVIS, and the 'female of superior attainments' was Miss HAYTER, who no doubt supervised the quilt. What better proof of the efficacy of her work (and proof that she had earned her free passage) than a quilt with a grateful and pious message on it?

The quilt has been made in the medallion style, and has a centre of broderie perse, an appliqué technique in which motifs are cut out of chintz and sewn to a plain background. Motifs include flowers and birds sewn down with a close herringbone stitch.<sup>7</sup>

Margaret ROLFE goes on to say that 'the quilt has been recently acquired by the Australian National Gallery from a private owner in Scotland.'

... It appeared that a number of pieces (more than twenty) had faded extensively ... however an examination of the back of the quilt reveals that these patches have been positioned and sewn back to front and had not faded at all! oversight would indicate that the work was carried out in poor light or by someone with failing eyesight ... There are a few patches marked with Everyday Art: Australian Folk Art dark brown small circular stains, identifiable as bloodstains, associated with pricked fingers. These stains are on the patches with the crudest of stitches and although the rocking of the boat may have led to numerous prickings, the cause of these stains appears to have been a lack of skill ... Possibly twenty different hands may be deduced (ie. the number of female prisoners undertaking the quilt).8

The Rajah Quilt, made on board the convict ship *Rajah*, in 1841, is the only surviving quilt known to have been produced during transportation. Acquired by the National Gallery of Australia in 1989, it has the honour of being the most written-about quilt in Australia.<sup>9</sup>

The Female Factory Historic Site Ltd, Degraves Street, South Hobart has negotiated the loan of the quilt as a special project within the Tasmanian Bicentenary, and it is expected to be displayed at the Queen Victoria Museum and Art Gallery, Launceston on 22 September 2004, and at the Tasmanian Museum and Art Gallery, Hobart on 8 November 2004.

Concurrent with this display, members of the Embroiderers' Guild of Tasmania will display a 'quilt' made as a tribute by the local embroiderers and bobbin lace makers.

### THE ROAD TO MOUNT BISCHOFF

(From our own Correspondent.)

#### **DEATH IN THE BUSH**

N Wednesday, the 2<sup>nd</sup> instant, a discrepid [sic] old man named Thomas Johnson, who had been engaged as cook for a party of men, contractors for work on the road to Mount Bischoff, breathed his last. He died rather of old age than from any particular form of disease. The authorities on the coast were at once made acquainted with all this, but it was not until Sunday, the 6<sup>th</sup> instant, that the order came up for the interment of the body. The manner in which this was effected was not creditable to those who are or ought to be responsible. The bearer of the order says that when he arrived at the hut where the party of men live, he saw the body of Johnson strung up to two saplings by means of ropes passed under his armpits and round his legs, and left thus exposed to every change of weather. Only two of the party would assist in burying the body, and as they could not let go the slings and hold the body to lower it gently, it fell to the ground with a regular thud. As it was in an advanced stage of decomposition, the men could not carry it to the grave made to receive it, and they dragged it there by a rope fastened to the legs and lowered it into the hole without shroud or coffin, and also without any of those rites by which men show their respect for the dead and for Christianity. It is to be hoped that such a distressing case of seeming heartlessness may never occur on the road to Mount Bischoff or anywhere else, and that "those who are dressed in a little brief authority" will see to such cases and at least accord to the

friendless dead such burial as is meeted to paupers.

You state in your "Home Letter" that the survey of the tramroad to Mount Bischoff is completed. On this point you have been misinformed; it will not be finished till January. When completed I shall write you on the subject.

## PIONEER JEWS REMEMBERED

Terry Lyons

N 15 February last, I conducted a unique Memorial Service at the site of the old Jewish Burial Ground, Invermay, Launceston, named Monash Reserve. I did this because my great-great-grandfather, Joshua LYONS,

was buried there. I am not Jewish myself-in fact. I am a Catholic Priest. But. since discovering in the early 1990s that my Lyons ancestors were Jewish, I have had a dream to 20 to Tasmania and visit my Lyons 'sacred sites'.

My recent long service leave gave me the opportunity to do this.

that the old Jewish burial ground in Launceston no longer contained any headstones, and was actually now a

Through my research, I had discovered

public park. In early 2003, when I first saw a photo of the large sign erected by the Launceston Council at the Park. I conceived the idea of erecting a bronze plaque there, and conducting a Memorial Service. I subsequently obtained permission from the Council to do this

So, when I left Townsville in September, 2003 to commence my six months' long service and study leave, I had in the boot of my car a cast bronze plaque mounted on a concrete desk, together with the necessary equipment to lay a solid concrete base for the mounted plaque. In the car I also had forty copies of the Memorial Service which I had composed.

I arrived in Tasmania in early February in my car, and in a few days had laid the

concrete base in preparation for the Service. I contacted the local paper and arranged an interview and photo of the site. This was subsequently published.

On Sunday morning 15 February at 11 o'clock, about forty people turned up for

the Service. Although it was not a Jewish religious service, the various prayers and readings were taken from the Jewish burial service, and the Hebrew Scriptures. Different people did the readings: the Mayor; the Jewish custodian of the Laun-

ceston Synagogue; a descendant of people buried there, and a lady who grew up beside Monash Reserve. ceremony began with an unveiling of the plaque, which contained the names of the twelve known burials. I gave a short talk on the history of the Burial Ground, which was purchased by the Launceston Hebrew Congregation in 1847. All the burials there took place in the 19th century. I also said the Mourners' Kaddish in Hebrew The Service concluded with the placing of stones on the monument a Jewish custom. Everyone found the whole Service guite moving.

Personally, I was deeply touched, and felt really connected with my great-greatgrandfather, Joshua. For me, it was the fulfilment of a heartfelt dream, and the highlight of my long service leave.

'Lest we forget.'

## MARITIME MUSEUM OF TASMANIA: CAPTAINS' PORTRAITS FROM GLASS SLIDES

S indicated in an earlier journal, the Maritime Museum of Tasmania (based in Hobart) has recently had most of its large collection of glass slides digitally re-photographed and a display mounted with bicentennial Portraits of ships' captains appear both in the exhibition and in flop books. A request for information which appeared in Tasmanian Ancestry in September, along with a list of the captains we had been unable to identify, was kindly responded to by several people. They went to a good deal of trouble to reach us, as an incorrect email address was given and we are most grateful for the help they provided.

There are over 90 of these portrait glass slides, as well as a large number of images of vessels, and most have now been identified. While the majority are master mariners, the title was also bestowed on others with limited qualifications such as river certificates. Coming from the O'MAY collection, they had been labelled simply with the names, often with no initial. A complication has been the existence of a number of members of the same family of the same or different generations. Some we have sorted out; others have eluded us We have now collected information about most of them, but welcome further input—not only on these, but on any other shipwrights, shipbuilders, lightkeepers other maritime or characters you may have among your ancestors.

While the Archives Office of Tasmania holds the great bulk of maritime information, and the TFHS Inc. is the first resource for family history queries, we receive frequent requests for information about 'captains' and other maritime people. We are keen to build up our personal files so that we can respond more effectively. This may be a good point at which to remind readers of TFHS Inc. member Colleen Read's useful publication, *Index to Agreements between Masters of Vessels and Crews signed on at Hobart 1850–1860*, which fills a previous gap.

Artefacts, documents and images with a Tasmanian maritime connection are the core of the museum's collection, and we hold some interesting personal material in our document archive, such as personal journals and diaries. Some of this material will be on show shortly, along with related artefacts, in our forthcoming exhibition 'Serendipity'.

## ROBERT ARTHUR ROBERTS' SOAP AND SALT MANUFACTORY

N 1819, the *Hobart Town Gazette* gave a 'method of making a good substitute soap, [that] may be worth the attention of the economical housewife'. It used, among other things, well burnt ashes of black wattle or she-

oak, mixed with green gum. The final result was a liquor capable of frothing like soap water, and in dilution with water, perfectly fit to communicate sufficient whiteness to linen.

The early mention of barilla was made in 1822. N. THORNTON cautioned the public against meddling with sundry items sold to him by

Thomas KENT, including a 'quantity of barilla, lying at Isthmus Bay', which is on Bruny Island in the south-east of the colony.

Robert Arthur ROBERTS and his family arrived in Hobart Town on board the *Brixton* in January 1823. In June 1823 Roberts was granted 500 acres of land at Barnes Bay, on Bruny Island, where, later that year, he was erecting buildings for the manufacture of soap and salt. The rapidity of the establishment of the works points to a prior involvement in the industries concerned. In early 1824 his works were called a 'manufactory of soap, as also of salt, ... upon a scale of sufficient magnitude to supersede a reliance on importation for the supply of both products.'

According to the *Hobart Town* Gazette of 9 January 1824, the quality of his output was 'highly credible to this colony'.

By 1824, Roberts was being credited with the discovery that barilla could be obtained in the colony from the 'Botany

Bay green' [Rhagodia baccal. Roberts' manufactory of soap and salt was still at Bruny Island in late 1824, and the soap making section seems to have been moved to Hobart Town by late 1825 or early 1826. The salt manufacturing side appears to have continued in Barnes Bay until possibly 1834 The 1834 Almanack refers to Mr

Roberts, the salt manufacturer. Major LENNON arrived and purchased the property in 1837.

The great art consists in incessantly stirring the ashes while they are hot until the saline matter collects in a solid mass. The burning should not be done on the sand, but on a clean rock or paved surface. A section of Pitt Water was known as Barilla Bay by August 1826, which suggests that barilla had been obtained from that inlet near Hobart Town.


Late in 1826 Roberts applied for permission to burn about five or six tons of barilla of a 'very Superior quality on Maria Island, off the east coast'. Owing, he explained, to a continued system of collecting this plant for a period of three years, a considerable deficiency is

experienced in procuring the necessary supply within a reasonable distance from Hobart Town. Roberts added that barilla was produced by burning a species of marine plant procured on various parts of the coast of this island [Maria].

The Government replied that the plant from which barilla is made cannot be procured there in any quantity worth the attention of the Government, and it

refused permission to Roberts.

In January 1827 ten tons of barilla from Preservation Island were transported to Hobart Town for the soap manufactory. In February, a cargo was obtained from George's River. In April 1827 a cargo of



Thus after about two and a half years of soap making, Roberts had started to go as far as the Furneaux Group Islands in the Bass Strait for barilla. It seems possible that by early 1828 he had exhausted all the barilla available on the south-east and east coasts of the mainland, and also on the Furneaux Group Islands.

A newspaper noted in August 1828 that

the great improvements lately made by Mr Roberts in his soap manufactory, which entitle him to the greater praise and patronage, as we all know the difficulty he had had to encounter in procuring the necessary materials in this infant colony; but these he has now procured, and the excellent quality of his soap proves he understands his business. We are informed he could readily sell more than he can at present make, and his

soap is universally called for in preference to any other.

By 1829 Roberts' Soap Manufactory was in Liverpool Street. By June 1832 the old soap manufactory was undergoing very considerable enlargement and improvements for the purpose of being converted into a brewery on an extensive scale. By January 1833 Roberts' Soap Manufactory was in Collins Street. He was still the

only Hobart Town soap manufacturer in May 1834.

In 1834 or early 1835 Roberts was still listed as a soap boiler, of Collins Street. The record of only one soap manufactory for Van Diemen's Land during the period 1824–1838 probably

refers to Roberts' successive works.

In September 1839 John McLAREN of Launceston gave his occupation as soap manufacturer. By 1840 Roberts the soapboiler had proceeded to Port Phillip (now known as Victoria).

About two years after production began, the capacity of Roberts' works was about two tons of soap a week and if it increased in 1828, more barilla would have been needed. The failure either to introduce exotic species of barilla shrubs, or to cultivate the native ones, would have been crucial factors in limiting the output of the colony's salt marshes. If Roberts had increased his output in order to supply an expanding market, the inevitable result would have been an inadequate supply of barilla.

Had the salt marshes of the north coast and the western Bass Strait islands not been worked for barilla, such a shortage would have developed sooner. Too frequent cutting of the barilla shrubs and the consequent exhaustion, for some years, of the local barilla supply, could have caused the cessation of Roberts' soap making. It may not be coincidental that barilla was being burnt in the Port Phillip District after Roberts went there.

#### **BACKGROUND**

Baths were not, in fact, to be found in most houses, and facilities for washing in the bedrooms were conspicuous by their absence. If rich men washed they did so under the pump in the yard.

It had always been the custom to make soap at home and the lye for it could be obtained from the ashes of the wood fires. Unfortunately the tallow (mutton fat) or other grease which had to be boiled up with the lye was also needed for making rush lights and candles and as mutton was not eaten much, supplies were scarce. The balance must nearly always have been in favour of light at the expense of The ordinary soap used in soap. farmhouses and cottages was made by mixing three parts of beech ashes with one part of quick lime, layer on layer, moistening gradually to slake the lime. The lye was then lixiviated with boiling water and concentrated to a density which would float an egg. This capital lye was saved. A less strong lye was boiled with the tallow or oil until it turned white. Capital was added in quantity three times the amount of fat used. It was boiled until it began to 'roap and run clear and transparent' from the ladle. A further three hours' boiling completed the process.

In Britain, soap manufacture was initially located around Cheapside, London, and in Bristol, but when by mid 19th century it became dependent on the new chemical alkali industry, soap manufacturing moved to Lancashire. Soap was heavily

taxed in Britain in the 19th century. In the 1820s, the tax rose to three pence (3d) a pound (lb) and the soap boiling pans had lids fitted that could be locked every night by the tax collector to prevent production under cover of darkness. Not until 1853 was this high tax abolished as a sacrifice to the kingdom of an annual revenue of a million pounds sterling. No information has come to light as to whether soap making was taxed at any time in Australia.

Even in late Victorian and Edwardian times, bathrooms were not normal apurtenances of ordinary houses. It was usual to bathe using a portable tin bath on the hearth rug before the kitchen fire.

In the country in 1913:

babies are tubbed somewhat severely till they reach the knickerbocker age, when they gain their freedom, and thereafter achieve the low water mark conspicuously between collar and neck below which soap seldom descends in after years.

## **TASMANIAN ARCHIVES ONLINE**

Jill Waters (Archives Office of Tasmania)

HE Archives Office of Tasmania has recently developed internet access to its Archival Management System, Archives One. The Archives One system was acquired by the Office in 1999 and it replaced a number of smaller databases and word documents that for years had existed independently from each other. Having an integrated system has allowed the Office to develop an interface for public access purposes.

Tasmanian Archives Online provides remote and search room access to the holdings of the Archives Office across many levels. Searching the database provides descriptive and contextual information on Tasmanian state and local government records and private records from individuals and organisations held by the Office.

This on-line searching allows clients to identify what records are available and enables them to plan strategies and to conduct their research in a more effective manner.

Copies of the records are not contained in this database.

database is structured hierarchical manner, providing links between different levels of information functions, agencies, series and items. It provides a basic search option across all information of and specialised search options for those with some experience with archival terms and arrangement. The functions module is still under development and will not display until later in the year. summary the database shows what is held, who created it, who can access it and where it is held.

Tasmanian Archives Online contains fifty years worth of data! It is updated on a continuing basis, particularly at the individual item level. It is important to realise, however, that the content of many items is not described in this database. For some major series of correspondence from central government agencies such as the Colonial Secretary's Office, Treasury Department and Lands and Surveys Department, individual files will never be described in the database by name or subject. The original indexes used by the agency which created the records should still be consulted where they exist. In addition, various card indexes in the Archives Office of Tasmania's search room should continue to be searched for additional information.

Currently there is no facility available for on-line ordering or viewing of records.

We strongly suggest that first time users consult the on-line instructions to understand how best to search the database. The Archives Office can be contacted by telephone or email to answer questions about the database and to make arrangements to view records in the public search room should they be held at the Office's Berriedale repository.

## CONVICTS ABOARD A SHIP OF DOOM-GEORGE THE THIRD

N 12 April 1835 the convict transport *George III* struck the submerged rock off Southport that ever since has been known by the ship's name. The vessel wrecked, with the consequent death of 127 convicts and six others. Twelve convicts had already died in passage. The following are salient points about the convicts, especially the 81 survivors.

- The survivors were decidedly not industrial workers. but generally craftsmen and labourers. approached a middle-class background. Half claimed full literacy, with another quarter able to read. Most gave detail family relationships. close Movement away from birth-place had been limited. Fifteen were married. twelve being parents, altogether having some twenty children.
- Information about the offence that caused conviction is available about all and about previous criminal activity for the survivors and some others. It does not appear that desperate want or even social alienation lay behind the generality of offences. Around half had previous convictions. The general concordance of George III men with the models proposed by Lloyd Robson and A G L Shaw is most evident in the overwhelming proportion of theft, in its many guises, among their crimes; it appears that only three of the 220 were found guilty of offences against the person. The proportion of lifers was 35%, a figure above the average, with 20% fourteeners, and 44% seveners.
- On the voyage the convicts generally behaved well, as judged by the surgeon. They yet followed their own agenda when it suited, notably in finding a means of drawing alcoholic spirit from the ship's store. When there was a spill and consequent fire, convicts were to the fore in quelling the danger. Perhaps a further style of selfwill was refusal by many to drink their cocoa ration. The surgeon believed the recalcitrants thus made themselves vulnerable to scurvy, which ravaged the ship during the last weeks of passage. There indeed seems to have been some relation between refusal of cocoa and falling ill, but cocoa itself is not an anti-scorbutic, so some mystery attaches to this issue. It was hope of saving sufferers' lives that caused the ship's captain to sail the quickest route to Hobart—west of the Actaeons, at night.
- When the ship struck, the ship's officers ordered the guard to keep convicts below deck. The argument went that should the men erupt, there would be utter chaos, dooming everyone. Guards shot two soldiers dead. Yet when the hatches broke, and survivors emerged, they were generally co-operative and some of them courageous. Were these people well equipped to deal with such a crisis?
- Among those who reached Hobart were 48% of the original seveners, 34% of the original fourteeners, 25% of the original lifers. These differentials appear significant, but of what? Ultimately, perhaps, in suggesting that

the shorter-term men had more will to live

- In their behaviour as Vandemonian convicts, *George III* men again accorded with Robson-Shaw models. The wreck, it seems, had effected no transformation of behaviour. From this point onwards, our people have interest because they were typical, not exceptional. On a rough differential of about one offence a year being 'minimal' misbehaviour, and double that 'moderate', with others 'extreme', the respective numbers in each category were 32, 34, and fifteen.
- Most 'extreme' was James McKay, notably well-behaved on board, yet who went to the colonial gallows for senseless murder. James Brown, like McKay, had been a soldier and a carpenter, yet he risked his life in attempting to save from drowning the local police magistrate, himself an army officer, who earlier had sentenced Brown to flogging. A third extraordinary case was David Jones, a hero of the wreck, who was a 'minimal' misbehaver in the colony, but offended more substantially on returning to Britain and so suffered re-transportation to Van Diemen's Land Jones now served at the pilot station at Recherche Bay, established in consequence of George III's wreck. showed no desire to remain near the site of his heroism, and soon escaped the colony.
- The men's post-convict life offers much interest to the researcher, but no less frustration. Five died while still under active sentence. Of the remainder no more than fifteen, and possibly fewer, seem to be recorded as having died in Tasmania. No doubt the records are somewhat defective, but

- still the evidence suggest that most of our men strove to depart the island, sooner rather than later. There is no reason to think they were untypical of convicts generally. Historians are interested in *settlers*, but *transience* is no less a part of experience at large, and seemingly that truth bears with particular force on Tasmanian convicts.
- Among those who did remain until death, or at least a lengthy while, there was a perceptibly large number of the remaining lifers. Apparent too is the of southern Tasmania. attraction especially Hobart, for this sample of ex-convicts. More important is the range of experience told by 'later lives'. A couple of the men became 'old lags' in the pejorative sense; others died in the asylums; some battled along; there was a handful of substantial achievers. Among the final group were John Gillon. Hobart stonemason; John Fidler, poundkeeper and carpenter at Glenorchy; and John Palmer, farmer east of Oatlands.
- Nineteen of the men married in Tasmania, one of them twice. Of these marriages, twelve were to women who had come as convicts and five to women who had never been convicts, with three wives untraceable. The first group produced twelve Tasmanian children, the second 39, and the third none. While obvious reasons help explain this differential, it remains striking. Broadly speaking, parenthood went along with a more positive and successful life

## CAMPBELL STREET GAOL INMATES 1873–1890 (ELKIN-GREEN)

HE following is Part 3 of names of inmates who were held at the old Campbell Street Gaol, Hobart during the years 1873–1890.

The original information was provided by the late Mr Ray HALL, a former chief prison officer, who kindly loaned me a gate-book that he managed to procure during the demolition of the old gaol during the early 1960s. To his knowledge, most, if not all, the other gate books and related prison information including records were destroyed during the demolition and in a later fire at Risdon Prison.

As the gate-book was hand-written some of the entries were hard to decipher. A question mark has been placed after the affected surnames.

Whilst visiting the Archives Office of Tasmania recently, I located several items of interest on the Campbell Street Gaol, which apparently managed to escape the ravages of two fires that destroyed much of the gaol documentation. One of these items featured a salary sheet that I feel is well worthy of publication

## THE MONUMENT ON THE HOBART WHARF 1804–2004

Irene Schaffer (Member No. 591)

N 1954 a monument was placed on the Hobart Wharf near the original Hunter's Island, the location of the British arrival in 1804. The monument was unveiled in 1954 by Her Royal Highness Queen Elizabeth II, when touring Australia and commemorates 150 years of British Settlement in Tasmania.

Some years ago, a small group descendants ofthose who arrived with Lieutenant Colonel Collins in February 1804. formed the Hobart Town First Settlers (1804)Association.

Since 1987, the members of this group have remembered their ancestors by placing a floral tribute at the monument on 20 February.

For the past ten years the association, under President Mrs Freda Gray and her loyal

committee, have worked continually towards making the Bicentenary one to remember.

On 20 February 2004 they had the largest attendance ever at their Floral Tribute day. This celebrated Tasmania's Bicentenary. There was also a dinner at the

Grand Chancellor Hotel attended by over 650 people. At the City Hall the following day, descendants displayed their family trees and met with relatives from all parts of the world. A church service was held at St David's Cathedral on the Sunday.

Plans for three new plaques for the

monument were not without some problems, but at the last moment all went according to plan. The names on the plaque were those settlers whose ship/ships victualled at Port Phillip 17 October on 1803 and whose voyage was completed at Derwent River on 31 Derwent 1804 under Collins' command Thev are of the official party names, free persons and their families soldiers prisoners, wives

and families of some of the prisoners, as well as some who had arrived with the first settlement at Risdon Cove in September 1803 or had arrived during this period.<sup>1</sup>

These were the 430 men, women and children who were to be the foundation of

the new colony of Van Diemen's Land. They survived many problems such as food shortages, weather, farming problems and later, bushrangers. Many raised families whose descendants of many generations still live here on this beautiful island.

The Hobart Town First Settlers (1804) Association members and friends produced a book for the occasion: *Heritage Stories of Van Diemen's Land 1803–04—2003–04* which contains over 80 stories.<sup>2</sup>

For many years now, I have been an honorary member through my connection with the Van Diemen's Land & Norfolk Island Interest Group and have shared many enjoyable hours with the group on my excursions and theirs. I felt very privileged to call Freda and many of the First Settlers my friends, and was proud to be able to share their day with them.

## EARLY HUON SHIPBUILDERS

Leonie Mickleborough (Member No. 20)

THE first shipbuilders to commence shipbuilding in a major way in the Huon were T INCHES, A HARLEY and J McLAREN. As young men they arrived at Hobart Town from Sydney in 1842, in a small brig. Their skill in all branches of shipbuilding became known, and with ample supplies of timber on the banks of the Huon River, they set up in business in the little bay north of Mr E GEEVES' shop. This soon became known as Shipwright's Among the vessels they built Point. were: Aeolus, Caledonia, Thistle, Rose, Rebecca and Triad (later named Beacon).

The keels of the Caledonia and the Triad were laid down at Desolation Bay. The pioneers suffered many privations and hardships in their search for timber. particularly in the upper reaches of the river. There they obtained Huon pine logs, which had to be rafted to the Point and cut into planks by the pit-saw Mr Harley later moved to method. Hobart and was joined by Mr ROSS. They laid down KENNEDY'S Slip at Battery Point. Messrs Inches and McLaren remained at the Point. former took an active interest in local affairs. He became a member of the Honeywood Road Trust, and on 1 May 1866 was appointed a delegate to wait on the Colonial Treasurer to urge that money be placed on the estimates to continue the Main Southern road to the Huon. Mr Inches died in July 1908.

have had an intriguing journey this past eighteen months. It began with records passed to me from a family member with our DRAKE and TAYLOR descendants from England. A good deal of the initial groundwork had been covered. As I now live close to libraries etc. I have taken on the task to find why Martha, Sarah and James Taylor emigrated to Tasmania and what their origins were in England.

Searching for Taylors in London is difficult. Numerous 1841 St Pancras films and baptism records of the children have been seen. Census records held no clues and I now realise the family lived outside the St Pancras area. Three steps away in one case! The Baptism records show where they lived (illegible) and that father James was a labourer and/or bricklayer.

While browsing at the Society's Launceston Branch Library recently I found the *Tasmanian Ancestry Index*. Looking for a few ROBINSONs and DIL-WORTHs was my goal and with time to spare thought I'd try some Taylors.

Nothing much until I found a fourteenyear-old query mentioning James, Martha and Sarah Taylor, all children who came on the *Boomerang*. My luck had turned! James had married. I was so excited—as were the staff on duty. So home to look at the *Tasmanian Pioneers Index*. I found James was old, a bricklayer, married as an adult, and died aged 81 at New Norfolk

I did abuse you Mrs Cunningham. Unfortunately you seem to have copied this off the *Tasmanian Pioneers Index* without checking the facts!

Next morning I looked at the details again. James Taylor was mentioned twice, once when marrying and once leaving a blank. I couldn't wait for the library to open at 9.30 a.m!

Marriage—nothing new there! James was married at Macquarie Plains. Death of Mrs Bridget Taylor—this was interesting. She died at Fenton Park. Death of James Taylor—hooray! James Taylor, bricklayer died at Fenton Park—informant—Sidney ILLSLOW, grandson.

All the information I had found in eighteen months came together, little clues with Fenton, Illslow, bricklayer etc. What a find, thank you Mrs Cunningham wherever you are—I'm sorry to have doubted you.

Now we have a clue why the Taylor children came to Tasmania aged 18, 17, and 14—to be with their father James. I am still looking for James junior born 1841, St Pancras London, an emigrant on the *Boomerang* in 1855.

Lesson: Never leave any page unturned—do your own investigating. You never know what you might come up with.

## CONVICTS AND BIGAMY GETTING IT RIGHT

Maree Ring (Member No. 552)

EORGE RUDE, in his article 'Captain Swing and Van Diemen's Land' published in Tasmanian Historical Research Association, *Papers and Proceedings* (THRA *P&P*) in March, 1964, found that twenty-five transported labourers who arrived 1831–36 were already married when transported—and remarried in Van Diemen's Land (VDL).

Rude suggests that some convicts 'got away with bigamy', though he names only one convict, David BARTLETT, who was charged with bigamy and this was seventeen years after his marriage in VDL in 1843. Rude implies that Bartlett was so charged as he had married in England then remarried in VDL—but was not charged until 1859.

In fact, this is not quite the case. Bartlett was married in 1843<sup>2</sup> to Mary Ann SKEWES.<sup>3</sup> Bartlett was a convict per *Eliza 2*, and arrived in VDL in February, 1831.<sup>4</sup> Mary Ann Skewes was a convict aboard *Navarino* which arrived on 17 January 1841.<sup>5</sup> They sought, and gained permission to marry.

For a second time in Tasmania (VDL), David, now using the surname of BARCLAY, married. On this occasion it was to Mary MITCHELLCOOK, in Hobart in 1856.6

According to *The Mercury* on 28 January 1858, Mary Ann was supposed to be still alive. Even though a newspaper cutting of a coroner's inquest for the death of an Elizabeth Bartlett, reported in the *Daily News* of 8 August 1855 was tendered as evidence, it was implied that his first wife

was still alive. It was these circumstances that brought the consequential charge of bigamy.<sup>8</sup>

Rude's original article was first published in THRA P&P then Protest and Punishment: The Story of the Social and Political Protestors transported to Australia. 1788–1868.

Henry FINLAY, who did some wonderful research on marriage, divorce and the issue of transported convicts marrying after seven years separation from their spouse, also referred to Rude's work. These mentioned articles all show that David Bartlett is the only married convict found to have been charged with bigamy from marrying after transportation.

It is hoped that this article corrects the misinformation by showing that Bartlett's first marriage prior to transportation was not taken into consideration for this charge, although he was guilty of bigamy by actually marrying twice in VDL/Tasmania.

# THE BIRTHDAY BOOK OF MABEL NICHOLS

Helen Emmett (Member No. 5401)

Bertha JOHNSTONE (née GOOLD) gave me a small Victorian Birthday Book. It had previously belonged to her mother (Beatrice Goold née Nichols), who in turn had inherited it from her sister Mabel Constance Blanche Nichols

The book is quite small, measuring 11cm by 7cm—it fits easily into the palm of a hand. The inside cover describes the book as being of 'Embossed Cloth, gilt edges-1s 6d'. It was printed by W Mack of 4 Paternoster Square, London and has three days per page with room for writing in names, and has a corresponding Bible Scripture for each day.

The Preface of the book reads:

This book is intended to serve a threefold purpose. Besides its general use for Daily Texts, it is so arranged that it may be made a Book of Autographs, and a record of the Birthday of Friends. It is handed by its owner to friends, that they may inscribe their names on the blank leaves opposite to the pages bearing the date of their respective birthdays; so that on these occasions they may be especially remembered in prayer. Thus it is hoped that it may be helpful in stimulating to the observance of the Apostolic injunction, 'Pray one for another'

Mabel C B Nichols was born at Oatlands in 1868, the second youngest daughter of George and Harriet Nichols (née

WEEDING). She was known as 'May' to her family. Mabel's parents moved from Oatlands first to Goulds Country near Fingal and then to 'Blackwood Park' Castra, behind Ulverstone, in 1882. The family cleared some of the first land in the Castra and Nietta areas. They later

lived at Railton where George Nichols died and was buried in 1895.

After the death of her father, Mabel, together with her mother and other unmarried sisters. Kate and Minnie moved to Forest Road. Hobart, where Mabel died in 1898. older sister Her lived Beatrice at Sprent after having met and married Albert Goold when the family had lived

at Castra. She inherited the Birthday Book after Mabel's death.

Additional entries were made by Beatrice and when she died, the book passed to her youngest daughter, Bertha. I have not included the entries made by Bertha in my list as they include many people who are still alive.

Based on the people who signed Mabel's book it appears that the first entries were made in the 1880s. I wonder if Mabel perhaps received the book for her own birthday. Often names appear in Mabel's own handwriting, other people appear to have signed the book themselves and a few have dated their entries.

The people in the book are a mixture of family and friends, many around Mabel's

own age. Several historical figures and writers also make an appearance.

I have endeavored to establish the relationship to Mabel of those who appear in the book. I found, however, it difficult to sort out some of the people who were clearly not family. I have

based notes for these people on the Tasmanian Pioneers Index. and therefore cannot vouch for the accuracy of my notes. The information relating to my Nichols/KIMBER-LEY/Weeding relatives is based on my research and that of my brother John Goold.

I would be interested to hear from anyone whose ancestors appear. For those who are

interested in their ancestors' signa-


tures, I would also be happy to scan or photocopy any page and send on request.

There are 235 entries in the Birthday Book of which I have included 131 in the table. Those with no explanation of a relationship to Mabel are presumed to be family friends.

**FFHS National Burial Index for England and Wales** Second Edition is available from 1 September 2004. Over 13 million records on 4 CDs.

The First Edition of the NBI, published by the Federation of Family History Societies (Publications) Ltd, was a major success and the Second Edition is expected to be even more popular. The number of entries has more than doubled, from 5.4 million to over 13 million burial records from Anglican parish, nonconformist and cemetery burial registers

throughout England and Wales. The records timescale ranges from 1538 almost to the present day. The information contained includes (where given in the original record):

- forename(s) and surnames;
- date of burial, age:
- details of place where the event was recorded: pre -1832 county; and
- the recording society, group or individual.

No monumental inscriptions or details of death registrations are included.

Records previously published in the First Edition have been included in this Second Edition to provide a single source of reference with a large number of these having now been checked and verified. This represents an increase of 50%. The number of records included have increased by almost 150%.

the installation program) of the original two CD set, together with the instruction leaflet which was inserted in the front of the plastic case, to the FFHS Publications Company. ### **BOOK REVIEWS**

The Family and Local History Handbook The Comprehensive Guide—8<sup>th</sup> Edition. Robert Blatchford (editor) Glossy cover, paperback. 448pp. Available from The Gould Genealogy Centre (formerly Gould Books), PO Box 675, Modbury, SA 5092. Phone: (08) 8396 1110 Price: \$38.00

The eighth edition of this invaluable handbook, although complete in itself, follows the format of previous editions, building on and complementing them. It contains a wealth of information for beginner and expert alike, as it covers all aspects of family and local history.

It would be impossible to cover the contents adequately. The section dealing History includes Local alphabetical listing by County, of History Societies and Organisations. Military History section is similarly organised with many interesting feature articles relating to all branches of the Services, plus details of Museums, etc. Over 90 articles beginning with 'Starting Out' and dealing with such wide ranging topics as Dr Barnado's, Grave Robbers, Lease & Rental Surveys, Captain Cook in Whitby and a whole lot more in between, make fascinating reading for the Family Historian

At the back of the book is the Genealogical Services Directory, a very useful section, which lists the names and addresses of Family History Societies, Record Offices and Archives, Cemeteries, Museums, etc., etc.

It will have a permanent place on my wish list of books to buy, for this and future editions, especially at the price.

William Sorell in Van Diemen's Land: Lieutenant Governor 1817–24. A Golden Age? by Leonie Mickleborough. Blubber Head Press, 2004, 167pp. \$25 at leading book sellers.

Leonie Mickleborough received a Master of Arts from the University of Tasmania in 2002 for her thesis on the seventh Chief Executive of Van Diemen's Land, Lieutenant-Governor William Sorell.

Two years later, based on that thesis, she has published this account of Sorell's seven years in the colony. As Leonie explains in the prologue, 'many accounts of early Van Diemen's Land have skipped rather lightly over the Sorell years', and, 'Sorell himself has been almost caricatured: on one hand as an adulterer and on the other as a charming and easy-going fellow'.

William Sorell arrived in the colony in 1817 and is remembered for many reforms during the seven years of his administration. The book explores Sorell the Governor, the charming and easygoing fellow, the adulterer and the family man. The result is a very well researched and interesting account of the fledgling colony and his influence on it.

It deals with the bushranger problem, early interaction between settlers and Aborigines and making education more accessible by increasing the number of schools. When Sorell took up his role in Van Diemen's Land, the convict system was in disarray and he set about putting some order into it, including the development of Macquarie Harbour as a secondary penal settlement.

There are extensive references and a very comprehensive bibliography. For students

of early Tasmanian history, this publication is a very welcome addition to the bookshelf. Congratulations, Leonie.

There is no doubt that by the time you've read through the contents of the CD you will be familiar with almost every public building and parish boundary in Roscommon.

The Roscommon Townland Index gives each townland along with its barony, civil parish, Poor Law Union and other registrar's districts, page numbers for Griffith's Valuations, the number of houses in the 1901 census and several references to different Family History Library (Church of Latter Day Saints) film numbers. The civil Parish database gives similar information, including the likely Catholic parishes for each area. The Catholic parish database gives detailed information on each parish, alternative names and the present parish in which it is contained. Griffith's Valuations Index for County Roscommon is included, along with a variety of lists of information pulled from Griffith's such as the location of corn mills, police barracks, institutions etc. A number of research notes are included, including listings of local history records at the Roscommon County Library. author's own tips on how to research. Roscommon history, an article index for a Roscommon historical society journal and examples of the types of records available for most parishes and townlands An interesting are also included. collection of websites and Roscommon newspaper links is also given. A variety of clear and detailed maps of the county are included.

I was disappointed that the inclusion of a few flashy title page tricks makes this CD difficult to access by anyone with a basic or old computer. It took three different computers and finally an Internet connection before this CD would actually auto start correctly as advertised. Despite installing the Adobe Reader 6 and Macromedia Flash 7 versions supplied on the CD. Autostart still brought up a blank window and the occasional message that I wasn't connected to the Internet. Recent advice from the author indicates that future sales will include an instruction sheet of how to get around this technical glitch. However, it wasn't until I went online to obtain another version of the file that it actually initialised and loaded the flash intro. Once it had, I wished it hadn't. An extremely annoving way file of pipes plays while the opening screen shows. Another click takes you to the introduction where Mr Hunter's opening can be read on screen, as he reads it aloud to you. You will become familiar with his reasons for making the CD as the intro is read every time this page opens and is linked everywhere. You are even instructed to print it as part of the 'using the CD' instructions.

Although the files open in Internet Explorer, the window eliminates the usual controls making it impossible to go back to the lists each time—instead you must return to the main menu and wend your way forward again.

This is a CD of limited interest to researchers and for Roscommon researchers it contains very few names beyond the Griffith's Valuations lists.

### **ANNUAL REPORT 2004**

ADIES and gentlemen I have much pleasure in presenting this, my third and final, annual report for the Tasmanian Family History Society Inc. As mentioned in my opening remarks in previous annual reports I have made mention of the many hours volunteers have given to our Without the help and organisation. dedication of our volunteers the Society would not function to the level of service that is given to our members and visitors that frequent our branch libraries on a regular basis. This help that is given may vary from a few hours at a working bee to a major transcription activity involving hours and hours per week over an extended period.

In this current era of knowledge transfer and availability there is a great concern that organisations such as ours, which survive on members joining to seek information, may suffer. This is due to the increased amount of genealogical information that is available on the Internet. If we are to continue to grow and keep a solid membership base we must offer better and more unique information than is available elsewhere. I encourage branches to think about how they can, encourage new members, create a 'Social' atmosphere to their branch library, and to make every one's visit to your branch an enjoyable experience.

As we are talking about membership numbers I would like to briefly give you the membership statistics of our Society. Three years ago when I came in as President I was concerned at our falling membership. From memory I think I suggested at the first meeting that I was President at, I said that if we continue the way we are going we will not have any

members in ten years time. I am pleased to inform you that for the first time in several years our membership numbers for the current year exceed the previous years number.

As a result of falling membership over the last few years, coupled with the fact that we have not had significant sales for state produced items, it was apparent that some decisions regarding outflows of state funds needed to be addressed. There were no corresponding inflows to counteract this situation. The state executive, after some debate and over a period of time during the last financial year, came to the conclusion that under our present funding arrangement of membership fees and other sources of income, some cost cutting measures had to be introduced. One of the first and most obvious was expenses incurred by branches that had traditionally been paid for by state, such as Post Office box charges. The respective branch will now pay these sorts of charges.

Perhaps one of the most difficult and hotly debated decisions that the state executive made was to cease the exchange journal process, as we have known it. Primarily the decision to discontinue exchanging journals was based on financial reasons. As you are aware the Society has been exchanging iournals with other Family History Societies, which are kept at the Hobart Branch and are available for loan to any member through their branch Exchange Journal Coordinator. Even though we have made a cost saving it can be argued that we have lost a continuing genealogical resource to the state. special thanks to Thelma McKay who has been the Exchange Journal Coordinator for the State, making sure that journals were dispatched to each branch every quarter.

As President of our Society, I have access to all Branch annual reports, and I must say I am very impressed at the level of activity that has occurred within the branches. Not only are there specific branch activities such as indexing of local papers etc. but also the involvement of members in State activities such as the RGD project which I mentioned last year. I am pleased to report that it is the intention to release on CD, using 'Digger' Tasmanian Births software. marriages up to 1919, Tasmanian Deaths up to 1930, plus Tasmanians that died overseas with the Armed Services up to 1922. No doubt this will be an excellent adjunct to the already released Tasmanian Pioneers Index on Digger. This is a project that has been ongoing with the RGD for some time and should bear fruition early in 2005. Once again a special thanks to all those volunteers that transcribed the information from metre wide registrars onto the computer database

eHeritage information. I am pleased to announce that the State Library who was overseeing the eHeritage grant has advised us that as we have met all the criteria, and that the eHeritage hardware comprising computer, printer and scanner that each branch received now officially belongs to that branch. I am also pleased to announce that the digital capture of headstones is continuing. With some branches the eHeritage project has been a very important project in updating their cemetery records. Also I have had reports of people requesting Digital images of ones that they have located on the Internet.

Some years ago research inquiries that we received from the general public were of quite some importance. Even now with the advent of the Internet it would seem that these queries would diminish somewhat. I guess that is true to a certain extent but it is surprising how many queries that we get, the difference being that the questions being asked are often more complex and difficult to answer than what they were a few years ago.

I would like to give my support to the incoming committee and wish them well and to thank all those delegates and executive members for their support and understanding that have been on the State Executive during my tenure as State President.

#### INDEPENDENT AUDIT REPORT FOR YEAR ENDED 31-03-2004

#### SCOPE
