A LETTER FROM VAN DIEMENS LAND JAMES IRONSIDE

Editors Note: The following letter was kindly sent to us by Mrs Joan M. Low of 16A Glenorchy Tce, Edinburgh, Scotland EMQ 2DQ. To the best of our knowledge this letter from early VDL has never been published before, and we thank Mrs Low for permission to use it in this journal. Mrs Low writes: "James Ironside was born in the village of King Edward (originally Kineddar) in Aberdeenshire in 1803. He was the son of George Ironside (1771-1829) and Helen Walker (1774-1829). Helen Walker was a sister of my great-great-grandfather George Walker (1776-1829). There is a little book about King Edward which gives some information about the family who were farmers. I noted from the book that 'In 1839 Robert Williamson was in Tasmania in business with an uncle.' Perhaps that is another lead for someone". Mrs Low would be pleased to hear from any possible Ironside connections.

RESEARCH NOTES: by Irene Schaffer

On 29 October 1824, the Hobart Town Gazette noted "Arrived on Friday evening last, the Brig Deveron, Captain W. Wilson from London, with passengers and merchandise". One of the passengers was James Ironside. The Deveron sailed from England in 1824 and having lost her foremast by lightening, put into San Salvador for repairs, which detained her for five weeks.

From information in the following letter, it would seem that James Ironside had read about VDL from a book published by Lt Charles Jeffreys RN in 1820 called Van Dieman's (sic) Land: Geographical and Descriptive Delineations of the Island of VDL and also probably from A Geographical Historical Topographical Description of Van Diemen's Land by George William Evans published in 1822. From both these books he appears to have formed a glowing picture of life in VDL, so much so that he decided to travel with the intention of settling.

It did not take long for James to discover that Jeffreys and Evans had, in his opinion, misled would-be settlers. He states that his fellow passengers "were very much disappointed, and that Jeffreys and (Evans) were abominable liars".

James himself was saved from too much disappointment on arrival by the kindness of Capt W. Wilson who had befriended him on the voyage out. A letter of recommendation for settlers (HRA III, IV, p101) noted Mr Jas Ironside as being recommended 10 April 1824. No land appears to have been taken up by him during this period.

Perhaps his disillusionment continued as he is named in the departures as seiling per Soveriegn from Hobart Twon to Port Jackson in 1827 (CSD 63/1 p330) No further information is available as to his further activities but, according to family legend, he later died at sea.

James Ironside

(The letter is addressed to the writer's brother, Mr John Ironside, 29 Great King St. Edinburgh)

Van Diemen's Land. Hobart Town. 24 August 1825. My Dear John.

I beg to acknowledge receipt of your favour of the 29th March 1824 which I received on board the Deveron at London - and which I am sorry has remained unanswered, but before proceeding into a detail relative to several points contained therein. I shall first add that after a passage of six months and six days - the Deveron came to anchor at H/Tn on the evening of the 22nd October. You have perhaps seen in some of the Edinburgh News Papers an account of the accident of which that vessel off the coast of Brazil about the end of July - I think the night of the 31st - which detained us a month in harbour before the masts were completed and equipped for sea - Had not this happened the D-n would have made this within the period of 4½ months another evil also followed in consequence of the time lost in refitting, we had to double the cape in the very middle of winter - consequently the Gales of wind which we experienced was considerable - I may say one lasted nearly 3 weeks during which time the Hatches were battened down which precluded us from any day light, our case can be better imagined than can be described -For my part I may say I never was in better health and could weather out any gale with less trouble than most of the Passengers - there were at first 14 Steerage p-- but 2 of them left us at Bahia - where we put into after being dismaster - who declared that trip we could never make - the object however was accomplished though the greater number of the Passengers found themselves very much disappointed - I however am not - having got a country situation as Superintendent to Captain Wilson having a House for myself and every thing that I want - It is to this Gentleman I owe my greatest share of thanks - Yet above all I would not recommend anyone to come out here unless they have at least 200 pounds, if they have that they can do very well, as to (Evans) and Jeffreys account of VDL they are abominable liars - little is to be seen which they represent. I mean in the manner represented still I cannot say the Country altogether deserves a bad name altho there is a medium for every thing - Bushrangers are great worries to settlers, for instance a young man newly arrived in the colony and who brought property to the amount of 700 pounds (as to Invoice) was last week robbed of every article excepting 2pounds which was in his Snuff Box taking the Jacket from off his back - and then leading him several miles into the Bush. caused him to drink a Pint of Rum and then left him, this happened as he was on his way into the interior - about from 30 to 40 miles from Hobart Town - he returned to Town without - shoes on his feet - apparently satisfied having lost every article in the world - the Two men that robbed him have been out these 10 months, there is now offered for their heads 170 pounds of land - this is not the only Robbery committed by them and others for not one week passes but what some settler is bereaved of all - Seven were taken last week and were to be hanged this morning - they

use very little ceremony here, and think nothing of turning off 7 or 8 altogether (not separately) there are now more than 100 B-rangers. Sheep stealing is carried on here to great perfection. They think nothing of taking from 2 to 3 hundred at a time and they too frequently get clear off with. In the meantime begin again at the first page -When you put my letter in the Post Office you must pay the Land Postage otherwise I will never get it. I will now turn to the several passages contained in your Letter - 1st "That my Father had taken or agreed with McIntosh for 10 acres of Land" - what absurdity would this be - can I imagine that such is the case and as you say 2nd "That our Brothers and Sisters must go to service" - I cannot express myself how truly deplorable the idea strikes me to the heart would to God it is not the case, how could he imagine that anyone would sanction that - if it is so I shall never correspond with him so much as to say I am well or ill - I beg you will write me immediately on receipt and state their circumstances as I shall not write until I hear from you - as to Geordie he knows I think where to go to - If not mistaken to Walkerhill - I suppose he meant or means to keep the younger Brothers and make them work like Henry keeping them in total ignorance bereft of all learning and above all given to swearing I trust as they rise in years that they may find out their error before it is too late and that things are going on better than I expect - I hope my mother is well and content altho I fear not - when you write remember me to her as likewise to my sisters and Brothers and Muckle Will as we used to call him. I am sure is grown a big man by now - If you are returned to Benff have the goodness to distribute my compliments among my old friends such as T.H. - Young and my much respected friend Wm Jeffrey Jnr (?) If in Edin. to John Thomson, H Adams (?) - I wrote my uncle at the same time via Auchingael - which perhaps he will get - have you succeeded as well as was expected in his case? -- The Earl of Fife's misfortune has reached this I am sorry for it - has my Grandmother and Aunty got clean off? When you write give me an account of the marriages. Deaths, etc omitting nothing that you can comprehend. John Wilson from Banff died here last week - the No. carried off just now is astonishing some days 3 & 4 - the Climate is reckoned good but the weather is remarkably changeable for instance it is fair just now I'll say but perhaps in the course of an hour it will or may blow a complete Murricane consequently sick people seldom linger, they either soon recover or go off quickly - nearly half the settlers are Scotchmen and generally in clusters together - as is a general remark in the street that Scotchmen stick close together - which is the case - The Kangaroos are very numerous in some parts up this Country - many a score have I killed with the Dogs they are very good amusement and some of them will overcome 3 dogs so that no help remains but catch hold by the tail and throw it upon the ground I mean on his side - they weigh from 100 lbs to 130 lbs -As I am turning towards a close and likewise turning scarce of what to

say, I must think of drawing to a conclusion and shall address you to the care of Mrs Davidson, Banff in case will find you out and observe when you write to address to the care of Wm Wilson Esquire C/- Hobart. In the meantime I remain My Dear John Your affectionate Brother, J.A. Ironside.

You would scarcely credit the number of People there are here from Banff and Aberdeenshire.

News from Branches

The format will be extended to include marriage, death, obituary and other notices that appear as news items.

SCOTTISH RESEARCH - USEFUL BOOKS & RESOURCES

This guide is designed to assist you with research in Scotland. A family tree names the members of a family, but a family history of that family may be much more interesting. Even if you know very little about your ancestors' lives in Scotland, a general picture of their lifestyles and occupations, their involvement in Scottish history and a description of their places of origin can usually be gained from the sources listed below. You don't have to go to Scotland for this information. Using your local library, genealogy society branch and postal services, you can do Scottish research without leaving Tasmania. When using postal services, send an sae and ask for an estimate of costs before committing yourself. Before buying books, check to see if it is available through local libraries or the genealogy society. Books not locally available may be obtained through inter-library loan nationally and internationally by placing your request with your local librarian. Old and rare books may not be available for loan but by supplying a specific request to your librarian (eq Burke's Colonial Gentry, Ralston of Hampden) the book can be located through inter-library loan and photo copies made of relevant entries. A small charge is made for photocopying.

Library Notes

(Lilian Watson has kindly agreed to take on the task of looking after the Society's main library. Welcome, Lilian, and thank you John Marrison for your good work as Acting Librarian after Theo Sharples' illness. Many people enquire after Theo, and will be pleased to know that she is well but taking a well-earned rest to consolidate progress. Ed.)

Just five years ago, on Christmas Eve, I was invited to examine our former Main Library premises at 3 Percy St, Bellerive. I dropped everything and went, and we were glad to have a few small rooms to use for the storage of our few books. We had limited funds and so scrounged for furniture and shelves and floor covering etc. Those rooms soon became too small and we began negotiations with the Clarence Council for a lease of part of the former Bellerive Post Office.

In July 1986 renovations began on this solid but old building. My husband Neil, Stan Black, Jim Wall, George Richardson, Ted Bezzant and others, repaired plaster, painted, removed fittings which were never intended to be removed, fixed locks etc. We ladies then helped clean floors and pack up the old library and then to unpack again. Over 150 hours of solid work were invested in this new venture and about \$700 spent on paint, plaster, timber etc. The electrical work needed \$550.

Now we have more space in a solid building which is well-placed for people arriving by bus or car. After visiting the G.S. of Queensland library at Stone's Corner, Brisbane, I can appreciate the ground level entry we enjoy. Would you like to climb two flights of stairs?

The opportunity is now ours to develop this resource centre. I feel it a privilege to be responsible for the library for a time, but it is ours not mine.

I have spoken with our former librarian, Theo, with many who give time as Library assistants, and with others who visit to get help. All comments and suggestions have been noted, but you possibly have other suggestions. I would like to learn of them. A note left at the library, or posted, would be great.

Remember that the library is a resource centre to help YOU to research more pleasantly and effectively. I saw many records in other Genealogical Libraries during my recent travels, and the material available excites me. Only a few years ago, one would need to travel to distant places or pay a researcher; now we can obtain many resources to use right here. "Hurry up and get them for us" you might say. Think again, we are all responsible for this library. If you learn of a book or microfilm you feel is important, write down its name and where it is from. If you need help with records of a particular country, let us know what you need. We all are part of the fund-raising team. By sharing the cost of an expensive book or set of micro-fiche we all can use it. Due to the expense

of moving and our new lease, our present purchasing power is diminished. It is up to all of us to assist as we can. When the Society of Genealogists needed to fund a new building, they called for donations ... and got them. We do not need to buy a building but we have a reasonable rent to pay. If 400 members of GST each donated \$10, we would have \$4000 to spend on resources all can use. Yes, you give only \$10 and gain the use of \$4000 worth of resources which you can help choose! That is what the GST is forsharing. Your donations are tax deductible too!

In October, on behalf of the GST Hobart Branch and Library, I spent several hours preparing a request for a grant of \$2500 from the Tas. Dept. of Sport and Recreation. Our need for index card cabinets is great. If approved in full or part, the money will be received in February.

We can raise funds by providing genealogical services by mail and by selling books, charts and leaflets. Give a book for Christmas! The best salespersons are those who know what they are selling. During those few idle minutes on library duty, read a leaflet or skim through a book we offer for sale. The reading materials are provided to help people. Sell a book or leaflet and you have helped and raised a few cents as well. Gould book catalogue is near the front counter, order a book through the GST and save postage and make the GST a small profit. Write down what you need and pass it to the library assistant.

Money alone does not make a good library. It is essential to have records readily available where you can easily find them. Library helpers spend many hours preparing index cards, some catalogues and arranging books. Loose papers need to be bound and labelled, letters need to be written to enquire about and order films and books, and four willing library assistants who arrive on time and cheerfully help inexperienced patrons are really VIPs. A treasurer who is honest and reliable is essential, as is a team to organise the cleaning tasks.

Behind the scenes, rosters are arranged, someone has to notify people of happenings, and reading machines have to be repaired. All these tasks and more have to be done to enable us to better enjoy the pursuit of our family records.

Your help for a couple of hours a month, could make a great difference. Those who live outside Hobart and can only occasionally visit the library, or make mail enquiries, are most welcome to offer suggestions or help. Brand new members as well as veterans are welcome to make suggestions and participate. New ideas are essential.

There is no limit to what we can achieve nor to the friendships which can develop in the process.

Book Review

"The Machanical Eye in Australia. Photography 1841-1900" by Alan Davies and Peter Stanbury, with assistance from Con Tanre. Published by Oxford University Press, Melbourne, 1985. Hard cover 22cmx30cm. 270pp. Black dust jacket with cover photo of 1859 Ambrotype. A reprint is now out, the text remains the same. Price now \$45. Some copies of first edition may be still available for \$25.

Alan Davies is Curator of Photography and Peter Stanbury Director at the University of Sydney Macleay Museum. This book is an excellent reference for the history of Australian photography and its photographers from 1841 to 1900.

Possibly of most interest to genealogists is the alphabetical listing of more than 3,000 professional and amateur 19th century photographers (many of them Tasmanian) along with known addresses and dates of operation. Other clues for dating of photographs are given by the recognition of costumes worn and by the photographic process used, from the daguerrotype and calotype of the 1840's and 50's to the gelatine paper platingotype of the mid 1890's.

Fifty two images along with details of the photographer, subject and date, make absorbing reading and fascination at the photos from the different eras. Throughout the book, there are some 42 examples of photographic advertisements of their day. These are entertainment in themselves.

This is an attractive publication and a valuable reference book, yet with the readability of a magazine - in all, a fascinating book which can be browsed through or read at length.

COMPUTER CORNER

GENEALOGY & THE COMPUTER

In recent years the personal computer has emerged as one of the most efficient ways of storing and compiling family histories. However, the purchase of a computer by a genealogist should not be taken lightly as it is a costly item and is of no value unless it performs the particular tasks you require of it. In response to a request in our 1986 September journal for information on computers and their use by fellow genealogists, we are able to give several individual experiences which may be of help if you are considering the purchase of a computer.

Mrs Kerrie Dick, a member of our Devonport Branch writes:-

"I use a <u>Commodore 64</u>. Quite some time ago I purchased a program called "The Manager". By making use of its many features, I was able to enter in my own requirements for my family tree details and the results were really pleasing. Comparison to a commercially produced genealogical program is very favourable.

Whilst I cannot produce a printed pedigree chart, there are other features that I have which are very useful. For instance I have allowed room to include all reference numbers to certificates I have. I find it very helpful to have RGD numbers next to the appropriate person, so that should I or anyone else need to find the certificate it is easily done. I've really enjoyed entering and editing my hard come by details on to the computer and having the means to quickly reproduce any part of it makes correspondence much easier. "

A Launceston member, Miss Karlena Nagle, also began with a <u>Commodore 64</u> but upgraded to an <u>Amiga Computer</u>. She writes:-

"I have been using a computer for 18 months to record the details of my family history. I started using a Commodore 64 and have now upgraded to an Amiga computer as I found I did not have sufficient memory capabilities with the C-64. The Amiga is a 512K memory system, with an 880K Double-sided/double-density disk storage. The cost of the system that I am currently using was \$3,200. This includes the computer, monitor, built-in 3.25 inch disk drive, mouse and operating software. This system is upgradable to an 8 mega-byte system by simply plugging in an additional "box". I intend to upgrade to this as soon as I can afford to do so, but it will take a while as I expect it to cost around \$5,000.

I use a database program to record the details. I looked at several prewritten programs but felt that they were too restrictive in the amount of detail you could record on each person. The database screens I have designed to use have 50 fields per person. These show name, date of birth death and marriage, place of birth, death and marriage, parents' and children's names, occupations, residences, and 10 lines for general notes. When printed out, this takes up about one full page. My program "Infobase" allows searching on any field and sorting for output on any field according to my needs.

The main thing that you need to do prior to purchasing a program, in fact even a computer, is to decide what details you wish to record, how many people you intend to record on each disk and the type of output required. Then allow for extra space. When you have completed this, look at the available programs for the computers you are interested in. Only if they are capable of meeting and surpassing your current needs are they suitable for your needs unless you are willing to write your own programs which can be very difficult if you are not used to doing so."

A Hobart member, Carol Hooke, overcame her fear of the "Electronic Beasty" to redesign a family chart to suit her personal needs. She says:"One Saturday afternoon while working on my research I decided that the chart I was using was not set out the way I would prefer it to be, so, seized by inspiration, I started chopping up an original, and moving the bits about, like men in a chess game, intending to re-stick them when I had achieved the desired effect.

After much fiddling, and several draughts from open doors, Hubby arrived on the scene, asking why I didn't use the computer - an Amstrad CPC 6128. Not having used the "Beasty" before, I was appalled. However, with his nouse, a word-processing programme, (which has functions that are similar to an electric typewriter), a printer, and my vague ideas about what I really wanted, we set to work. By tea-time, we had a personalised form. Deciding what to put where took up most of the time. It REALLY was easy."

PROFILE OF A PENGUIN PIONEER

James Hales was born in the coastal town of Lowestoft, Sussex in 1826. In his youth, he learnt the craft of shoemaking, but later joined a ship where he worked with sailmakers. He spent about ten years at sea before landing in Melbourne at the time of the gold rushes in the early 1850's. He did not go to the goldfields, but remained in Melbourne, working as a tent-maker.

It was in Melbourne that he met Eliza Ann Russen who had emigrated to the colony of Victoria in 1852. They were married at St Peter's Church, Eastern Hill in 1853. Their first child Eliza Ellen was born the following year.

Sometime in 1855, the family left Melbourne for Tasmania, to take up tenant farming in the area just east of the Forth River, known as Norfolk Creek. They rented land from James Brown. While living there, they had four more children: John Charles, Amelia, William and James Henry.

In May 1861, James Hales and his neighbour John Merelie Smith went to the Penguin Creek area to select land. James chose 100 acres and John 131 acres on adjacent blocks. It was not until May 1863 however, that the two men and their families occupied their properties, placing them among the pioneers of the district. As was the practice at the time, it is probable that, after selecting their land, the two men made occasional trips to the area to build their houses, only moving in when the work was completed.

The town of Penguin was one of the strong-holds of the Primitive Methodist Church in Tasmania and the Hales family were devout members. James was Superintendent of the Sunday School from its establishment in 1863 to his death in 1888. James Henry was later to become a local preacher and Amelia (a home mission collector herself) married Richard Hilder, a local preacher in the Burnie area.

On January 23, 1869, James' wife Eliza, died in childbirth. She was 38 years of age. She had had eight children: Eliza Ellen, John Charles, Amelia, William, James Henry, Robert George, William Henry and Alfred.

Twelve months later, James Hales married Jane Parsons, the eldest daughter of John Parsons, an emancipated convict who lived in the Leven area where he farmed and was the mail carrier. There were ten children of this second marriage: George, Edwin, Lucy, Margaret, Walter, Charles, Ernest, Maybella, Edith and Frank.

James Hales died in Launceston on 14 June 1888 and his body was transported by rail, back to Penguin, where he was buried in the local cemetery. At this stage of research over 1,000 descendants have been traced, many of whom still live on the North West Coast of Tasmania.



ZACHARIAH BROOKS & HIS MARRIAGES By Elisabeth Blizzard

Editor's Note: This article is reprinted from the journal of the Oxfordshire Family History Society by kind permission of the author and editor. It was brought to our attention by Irene Schaffer, who was able to assist Mrs Blizzard with Tasmanian material. Mrs Blizzard came across Zachariah Brooks while transcribing parish registers, and a special display featuring this story has been planned to assist the parish funds.

Penelope Renold, editor of the Oxfordshire FHS Journal writes:- "The marriage tangle, with each partner simply 'marrying' someone else after a while, without formalities! Such a situation must, in fact, have happened relatively often. Tasmania was, after all, a long way from home with little prospect of ever seeing one's original friends again. Assisted passages of convicts or ex-convicts' families did happen, but they must have been very few. For the wife left behind, too, the situation was the same in reverse. However, it creates difficulties in tracing ancestors".

Zachariah Brooks married Sarah Heath on 7 November 1814 in Longworth Parish Church, then in Berkshire. They had four children: Jane, baptised 1817, George in 1818, Eliza in 1821 and Adam in 1822. But then, on Monday 7 July 1823, at the Berkshire Assizes, Zachariah was sentenced to seven years transportation for 'housebreaking at Longworth, and stealing a coat, hand-kerchief etc., the property of Wm. Grainger'. On 6 April 1824 he sailed for Van Diemens Land (now Tasmania), one of 180 convicts on the ship 'Chapman'. His convict indent states that he was 37 years old, 5ft 3in in height with brown hair, dark grey eyes, by trade a ploughman and labourer. His native place is given as Swindon, and the only distinguishing mark was a scar on the back of the ring finger on his left hand.

On arrival at Hobart, he was assigned to Mr Bisdee, and his name appears on the Annual Return of Convicts for 1825 and 1830 - still working for Mr Bisdee. Unlike most convicts, who had long lists of convictions after arrival, Zachariah had none. His free certificate was granted on 11 August 1830, No. 1830/234.

Sometime before 1832 Zachariah visited the Female Factory in Hobart Town to choose a wife, and he married Catherine Higgins. She was an Irishwoman and a convict who had been sentenced to fourteen years transportation at Glasgow on 11 April 1829 and who was married with three children, and was of "bad character and connexions". Nevertheless, they were married in Hobart Town, Zachariah being described as a bachelor, and Catherine as a widow! Unlike her husband, she had a long list of convictions in the colony for drunkenness, disorderly conduct, and 'being found in an indecent situation with a man after hours'. Her first conviction was only three months after her marriage, but even so Zachariah described her as being a very industrious woman. She was granted a ticket of leave on 16 October 1843.

On Census night, 6 February 1843, Zachariah was living with Catherine in Harrington St, Hobart, and is described as the householder and employer. The house belonged to a Mrs Cash, and was built of brick and completed. Also living in the house were three single men who had arrived as free settlers. Zachariah was still working as a ploughman, and is described as "free by servitude"; he died on 6 April 1852 aged 63, in the Colonial Hospital, Hobart Town. The stigma of having originally been a convict was never lost, and also recorded in the entry to be found in the Register of Burials for Holy Trinity Parish in the County of Buckingham, is the name of the ship 'Chapman' on which he had travelled as a convict, and the initials 'F.S.' meaning free by servitude. There is no record that this couple had any children.

Meanwhile, back at home on Longworth, his wife Sarah had two illegitimate children: Mary Ann. baptised in 1827 and Harriet in 1831. Against the second entry the Rector noted in the margin "a married woman her husband having been transported beyond the seas upwards of 7 years."

In the Longworth Vestry Book for this period there is the following entry: "In June 1832, 100 pounds was borrowed by the Parish in part to defray the expenses incurred by purchase of land in New Brunswick, tools etc. for the provision of the following persons being Parishioners of Longworth who were desirous of emigrating to the Place ... William Painton and his wife, John Painton and 6 children, John Prior and his wife and 2 children, Charles Austin, James Ridge, Thomas Painton and Sarah Brooks and 6 children." Could Thomas have been the father of Sarah's two illegitimate children, and together with Zachariah's four, he and Sarah sailed to New Brunswick to live together as man and wife and begin a new life?

There is no further record in any of the Longworth registers of Thomas Painton, Sarah Brooks or any of Sarah's six children.

It was the note against Harriet's beptism in 1831 about Zachariah's transportation that started me on the search for him, to find out what happened to him - a search I have found fascinating, which opens up a whole new insight into the transportation of convicts to Australia and Van Diemens Land, and the tangle it could make of marriages. I should like to add that without the willing help of the Genealogical Society of Tasmania I would have been unlikely to have found out what happened to Zachariah. As a footnote - I have made contact with a descendant of two others of the emigrants, John and Rebecca Prior, and hope to find out what happened to them in New Brunswick, and maybe about the other emigrants also. It would be of great interest to find out what became of Thomas Painton, Sarah Brooks and her six children.

INDEXES

Immigration Deposit Journals 1853-1900 NSW

These journals are currently being indexed, and the period 1853-8 will be completed by December 1986. They record monies deposited in the Colony by persons wishing to sponsor the immigration of a nominated person or group of persons, frequently members of their own family or persons they wished to employ.

The amount of information provided varies over the period and include name of depositor or sponsor, date of deposit, name, age, calling and address of immigrant, nationality (English, Scotch, Irish, Foreigner) of immigrant, ship and date of arrival and, if necessary, date of refund of deposit on account of non-arrival of nominee. Many months would usually pass between the deposit of the money and arrival of the immigrant and this should be borne in mind. Please send \$2 plus sae for each enquiry (with name variations if applicable and approx time period). The National Index of Parish Registers for Wales has now been published.

<u>Lincolnshire</u>: The Lincolnshire Family History Society has almost completed an index of all the surnames in the 1851 census of the county and is planning to start on the 1881 census.

Dowling's claim to have perfected an instantaneous process, he charged extra for children under five years of age.

One of Dowling's compension, George Cherry, priced his carres-de-viaise in a more forthright manner. "Price of ALBUM PONTRATTS, 3s. 6d. for the first impression, and 1s. 6d. each for exita copies. Children under 4 years of age excepted, for which double price will be charged."

The delightful sign "Children Executed from 10 to 4" over the newly opened Half Crown Studio probably encouraged patronage."

Application for Membership forms may be obtained from Branches or the GST Secretary and be returned with appropriate dues to a Branch Treasurer, or sent from out of state to the GST Treasurer, Box S40G, Hobert, Tas. 7001. Dues will also be accepted at Branch General Meetings or at the Libraries.

The MAIN Library is in the old Post Office at the corner of Cambridge Road and Queen Street, Bellerive, and other branches at Hudnville, Launceston, Devoncort & Burnie, also have libraries. Access is free to members, but there is a charge of \$3.00 each session to non-members at the Main Library. & ALL users of Microfiche or Microfilm Readers are charged \$1.00 per hour extra. Books, journals from various genealogical societies, Indexes to transcribed tombstones, indexes to Births, Deaths & Marriages in the 'Mercury' and a register of Tamily names and charts may be consulted at the Main Library, and books, notes and charts may be purchased there.

Donations to the Library Fund (\$2.00 % over) are an allowable tax deduction. Gifts of family records, books, maps, photographs etc. are most welcome.

Research is handled on a voluntary basis in each branch. Simple queries from members will be answered on receipt of postage and self-addressed envelope. For non-members there is an additional fee of \$2.00 for simple queries. A fee of \$5.00 will cover research for half an hour in our own library only. A list of members willing to undertake record-searching on a PRIVATE BASIS can be obtained if records outside the G51 library are required.
